
# Dasher Board Advertising at Eagles Ice Arena Contract

## **Advertisement Terms & Conditions**

- The sponsor must provide their own artwork of their company logo, slogan, phone number, etc.
- Any additional fees (approximately \$35-\$75) to convert a jpeg image into a quality printable file will be at the expense of the sponsor.
- The dasher board numbers are on a first-come first-serve basis. If you are unable to receive your preferred options, Eagles will contact you with an updated chart to allow you to select a new number.
- The sponsor should be aware that dasher board numbers 24-27 & 54-57 are high volume areas and have the potential to receive more damage than the other advertisements.
- Should the sponsor wish to change the layout of the ad during this contract, it will be at the expense of the sponsor.

### **Payment Terms & Conditions**

- Please make all checks payable to Eagles Ice Arena: payment method will include Cash or Check.
- First year's payment will be due the day of the contract. However, your commitment will not start until we install the advertisement on our boards.
- If a sponsor selects a 3- or 5-year commitment, you will be invoiced annually on the date of installation of your advertisement. You will lose your 2<sup>nd</sup> and 3<sup>rd</sup> year price discount if invoices are not paid within 30 days.

#### **Discount Terms & Conditions**

- If a sponsor is interested in purchasing an advertisement on Rink 1 and Rink 2, a 25% discount will be applied to a second board advertisement for Rink 2.
- If a sponsor selects a multi-year commitment & pays the total balance up front, a 5% discount will be applied.

#### **Contract Agreement**
